We seek a dedicated and compassionate part-time speech therapist to join our team in a unique day program setting. The Neurological Rehabilitation Adult Day Program (NRADP) services individuals with neurological injuries or disorders. The NRADP strives to support all physical, mental, and social goals with the participants and their caregivers to improve functionality and restore independence. This position will be performed onsite at the facility located in Lakewood, CO.

- Conduct comprehensive assessments of speech, language, and communication abilities.
- Develop and implement personalized treatment plans based on participant evaluations
- Provide therapy sessions to improve speech clarity, language skills, and communication effectiveness.
- Educate participants and their families on communication strategies and techniques for improvement.
- Collaborate with other therapists, rehab aids, and caregivers

- Monitor participant progress and adjust treatment plans to achieve optimal outcomes.
- Maintain accurate documentation of participant assessments, treatment plans, and progress notes in compliance with regulatory standards.
- Maintains HIPAA compliance
- Attends community outings and treats accordingly in a community setting

#### **Qualifications:**

- Minimum Required Education: degree in Speech Pathology
- Required Licensure/Certification: Current certification with the Colorado
  Department of Regulatory Agencies to practice Speech Pathology is required.
- Willing and available to work *within* the hours of 9 am 2 pm, days Monday-Friday to work with the participants in the day program setting
- Strong participant assessment and care skills are necessary for effective therapy delivery
- Observe participant conditions or changes in conditions
- Excellent communication skills are required to interact effectively with participants, caregivers, and multidisciplinary teams.
- Ability and willingness to work in a team environment
- Must be able to pass all Colorado and Federal background checks
